



Konstitutionelle Methode:

- Krise des europäischen Nationalstaats --> Einzige Lösung europäische Föderation
- „revolutionäre Bewegung“ sollte eine Verfassung in Kraft setzen
- europäische Integration durch einen verfassunggebenden Akt
- Schaffung gemeinsamer supranationaler Organe zur Sicherung des Gemeininteresses
- Sah 1952 die Gründung der EGKS nicht hinreichend demokratisch legitimiert, nicht durch verfassungsgebende Versammlung sondern durch internationalen Vertrag gegründet
- vereinigtes Europa war für ihn zugleich Voraussetzung für die Befreiung der Arbeiterklasse und die Überwindung des Kapitalismus

Monnet Methode:

- neofunktionalistische Integrationskonzept „der Dynamik in kleinen Schritten von nachhaltiger Bedeutung“
- Konkrete Solidarität der Tat
- Ökonomische Instrumente als Mittel der politischen Integration
- Im Konsens getroffene Eliten-Entscheidungen
- Etappe(n) auf dem Weg zu einer noch wenig ausgeprägten finalité








Gare Luxembourg 1993






Plan du troisième niveau par lequel l'ensemble du site est accessible de l'intérieur.
